Membership Requirements

Regular Members

Individuals operating as sole proprietorships, partnerships or closely held corporations which are primarily engaged in the production and/or marketing of agricultural seeds may be elected as regular members. Regular members may have their principle place of business outside the United States. The directors may from time to time prepare guidelines to be utilized by the board or any admissions committee in considering applications for membership to the corporation. In making any such guidelines, the board shall recognize that one of the principal purposes of forming the corporation was to provide assistance to closely held seed companies which are independent business organizations and not subsidiaries of publicly-held corporations.

Associate Members

Individuals operating as sole proprietorships, partnerships or corporations which are engaged in activities that relate or contribute to the activities of regular members may be elected as associate members. The board of directors shall have sole authority to determine what standards and conditions shall be established from time to time for the selection and election of associate members.

Affiliate Members

Any association or agency officially organized and operating with interests directly related to the activities and purposes of IPSA but not meeting the qualifications for regular or associate membership may be elected as affiliate members. Affiliate members may represent state and regional trade associations, crop improvement and seed certifying agencies, associations of seed technologists, and other seed-related or agricultural support organizations. The board of directors shall have sole authority to determine what standards and conditions shall be established from time to time for the selection and election of affiliate members.
